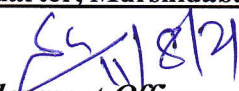
**ELIGIBLE CRITERIA FOR THE POST OF "DATA ENTRY OPERATOR"**

- 1) **No. of post:** 01 One post for Beldanga-II Development Block.
- 2) **Age limit:** 18 years to 40 years as on **01.01.2021** (upper relaxation of age as per Govt. norms).
- 3) **Qualification:** Graduate in any branch with certificate in computer application.
- 4) **Selection:** Selection of DEO (data Entry Operator) will be done by the respective Selection Committee. The such Data Entry Operator will be engaged on contractual basis and will be for a period of 1 (One) year or less subject to renewal of contract on monthly or yearly basis by head of the Department / Office & engagement may be terminated at the completion of Job or at the end of the Project whichever is earlier and may also be terminated by the Head of the Department / Office on the basis of recommendation of IT Dept/ NIC Project leader or Project-in-Charge for unsatisfactory service, misconduct etc. of the incumbent concerned.
- 5) **Professional fees:** Engaged / appointed DEO will get professional fees at a consolidated rate of Rs. 13,000/- (Thirteen Thousand) only per month in terms of F.D's Memo No. 5859-F(Y) dated 22.07.2013 also as per P.D, CMDMP Memo No. 303(21)-ES(CMDMP)/ESTT-05/2013<sup>PT</sup> dated 1905.2014 & as per P.D, CMDMP Memo No. 39-(26)-ES(CMDMP)/ESTT-05/2013<sup>PT</sup> dated 14.02.2019.
