#### Selection procedure:

i. Individual admit card of eligible candidates having date, time and address of the written examination center will be sent by post.

ii. Eligible applicants for the post no. 1 will appear in the written test of 80 marks.

a. English: 15 marks b. General Studies: 20 marks c. Subject specific issues: 45 marks

iii. Eligible applicants for the post no. 3 will appear in written test for 80 marks.

a. English: 20 marks b. General Studies: 40 marks c. General Knowledge: 20 marks

iv. The successful candidates on the basis of marks obtained in the written test will be called for Computer Test of 10 marks. No computer test for candidates for the post Ayah.

v. Candidates who succeed in the Computer Test will, in the ratio of 1:5, will be called for Viva Voice Test carrying 10 marks. For the post of Ayah Viva Voice Test will carry 20 marks.

vi. Selected candidates will be called for Walk-in-Interview for the post of Doctor (Part Time).

vii. The Selection Committee will submit the merit list of successful candidates in the ratio of 1:4 to the District Child Protection Society / Unit for approval and appointment.

viii. The list will be valid for 2 (two) years from the date of approval of the list by the DCPS / DCPU.
