In terms of Memo No. HFW-27011/375/2018-NHM-SEC-Dept.of H&FW-Part (2)/3692 dated 03/12/2021 of the Mission Director, Secretary, H&FW Dept. Govt. of West Bengal, if any eligible SC/ST candidates are not available amongst the applicants for any village reserved for particular category as mentioned above, eligible 'General Candidate' may also be considered for selection abiding by the selection process and guidelines.

Eligibility:

- Should be Married /Divorced or Widowed women
- Should be a resident of the same village for which she will be selected
- Should be within the age group of 30-40 years. In case of SC and ST candidates, the lower age limit may be relaxed to 22 years (cut off date of age as on **01/01/2022**)
- Should be Madhyamik Examination appeared or equivalent
- Women candidate who have passed Madhyamik examination or possess higher qualification, only marks obtained in Madhyamik or equivalent examination will be considered.

Mode of Application:

- Candidates should submit application in the format annexed as **Annexure "A"** in this notification
- Application should be in A4 size paper on one side only and should be clearly legible.
- Application Form may be downloaded from the website : <http://uttardinajpur.nic.in>
- One candidate is allowed to submit only one application; if more than one application is submitted by the same candidate; her candidature shall stand cancelled.
- Candidate may obtain information from their respective Health Sub Centre / GP Office / BPHC.

Documents to be submitted with the application (Photo copy with self attestation):

1. Proof of Date of Birth (Birth Certificate/ Admit Card or Certificate of Madhyamik Examination)
2. Proof of Residence (Voters Identity Card i.e. EPIC / Ration Card)
3. Proof of Marital Status of the candidate: Married/ Divorced/ Widowed as the case may be
4. Original Mark sheet of Madhyamik or equivalent examination as applicable, Mark sheet is to be provided by the candidates even in case of failure in the exam,
5. SC/ST Certificate wherever applicable.
6. Two copies of Passport size photographs; one pasted on the application form (signed diagonally) and the other for office use (signed diagonally on the back side)
7. One self-addressed envelope affixing postage stamp of Rupees 5 (five)
8. Experience certificate, in case of Grade-I & Grade-II SHG members/Trained Dais/Link workers.

Whom and how to Apply:

1. Candidate may submit the application in the **DROP BOX** kept for the purpose at the respective Office of the Block Development Officer concerned on or before the closing date & time, i.e. up to 31/01/2022 by 5:00 pm only on Govt. working day and during working hours.

- ❖ Selection is based on marks obtained by the candidates in the Madhyamik/ equivalent examination (90% weightage)
- ❖ Score in the interview (10% weightage)
- ❖ In respect of villages where the vacancies are reserved for SC/ST, the guideline provided in Memo No. HFW-27011/375/2018-NHM SEC Dept. of H&FW- Part (2)/3692 dated 03/12/2021 of the Govt. of West Bengal, Health & Family Welfare Deptt. (NHM) will be followed.
- ❖ Preference to be given to Grade-I & Grade-II SHG members/Trained Dais/ Link Workers keeping the selection criteria fixed.
