#### 3.2 Economically Weaker Section (EWS):

Candidates seeking benefit of reservation and relaxation shall submit caste certificate in prescribed format issued by Competent Authority. In case of EWS category candidate seeking benefit must submit income proof issued by appropriate authority. The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in the prescribed format shall only be accepted as proof of candidate's claims belonging to EWS:-

- (i) District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/ Additional Deputy Commissioner/ 1st Class Stipendiary Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate / Executive Magistrate, Extra Assistant Commissioner.
- (ii) Chief Presidency Magistrate/ Additional Chief Presidency Magistrate/ Presidency Magistrate
- (iii) Revenue Officer not below the rank of Tehsildar and
- (iv) Sub-Divisional Officer or the area where the candidate and /or his family normally resides

### 4. APPLICATION FEE:

The applicant shall be required to pay Application fee of Rs. 590/- (Application Fees Rs.500/-+ GST @ 18% = Rs.90/-) through Demand Draft with the following conditions:

- (i) Demand Draft for the requisite fee should be drawn in favour of "NIFT Kolkata" payable at Kolkata.
- (ii) Applicant must write his/her name, address and post applied for on the back of the Demand Draft and must enclose the original Demand Draft with their application forms.
- (iii) The fee once paid shall not be refunded or re-adjusted under any circumstances.

- (iv) Candidates belonging to SC/ST/PWD/ Women candidates and employees of NIFT (both regular & contract) are exempted from paying the Application fee.
- (v) The candidates applying for more than one post, shall be required to apply separately along with the required application fees for each post. However, applicant should choose the post for which he likes to appear for the exam in case he becomes eligible and selected for more than one post.
- (vi) Demand Draft should have been drawn on or after the date of publication of this advertisement.

#### 5. CONCESSION & RELAXATION:

- a) Age relaxation to SC/ST/OBC: The upper age limit is relaxable upto 05 years for SC/ST and 03 years for OBC subject to production of Caste Certificate issued by the Competent Authority. For availing the benefit of Other Backward Classes, the candidates are required to produce the latest OBC non-creamy layer certificate on the prescribed performa applicable for appointment to the post of Central Govt.
- b) Age relaxation to Persons With Disability (PWD): Age relaxation of 10 years is allowed (total 15 years for SCs/STs and 13 years for OBCs who are PwBD). The persons claiming age relaxation under this sub-para would be required to produce a certificate in prescribed proforma in support of their claims clearly indicating that the degree of physical disability is 40% or more. In any case, the appointment of these candidates will be subject to their being found medically fit in accordance with the standards of medical fitness as prescribed by the Government for the each said individual post.
- c) The benefit of reservation under EWS can be availed after production of an income and asset certificate issued by the Competent Authority.
- d) Maximum upper age-limit for NIFT employees may be relaxed upto five years or total length of service rendered (on regular and/or long-term contract basis). This is over and above the relaxation prescribed for SC/ST/OBC (NC) & PwBD.

#### 6. Scheme of Examination:

The selection process to the vacant posts may include written test and/or skill/competency test. The written test will be followed by Skill/ Technical Test of the selected candidates as applicable. The Institute reserves the right to admit only that many candidates as considered necessary for Skill/ Technical test based on the performance of candidates in the written test and/or skill/ technical test as the case may be.

#### 5. HOW TO APPLY:

- 5.1 Application forms can be downloaded from NIFT Kolkata website (https://www.nift.ac.in/kolkata/careers). Applications, duly filled in the prescribed proforma, should be addressed to the Joint Director, National Institute of Fashion Technology, NIFT Campus, Block-LA, Plot-3B, Sector-III, Salt Lake City, Kolkata-700106 and shall be submitted in a sealed envelope superscribed with "Application for the post of \_ ". Self Attested copies of relevant documents, certificates and testimonials as proof of Age/Date of Birth, Educational Qualifications, Caste, Experience, etc. should be attached with the application form. The Demand Draft drawn in favour of 'NIFT Kolkata' payable at Kolkata should be attached with the application form. The demand draft should not be tagged or stapled but should be pinned or clipped at the top of the application form. Applicant should mention his/her name and the post applied for at the reverse of the DD.
- 5.2 Those candidates who are employed in Government Departments and/ or PSUs/Semi Govt./Autonomous Bodies under Government should send their applications <u>Through Proper Channel</u> along with "No Objection Certificate" from their employer stating that the applicant if selected will be relieved within one month of the receipt of the appointment orders. The vigilance clearance should also be recorded.

- 5.3 While applying for the posts of Lab Assistant, Competency Code should be mentioned in the application form. The detail of the competency code is mentioned in the Eligibility Requirements for post of Lab Assistant (refer Annexure A5.1).
- 5.4 Only female candidates are eligible to apply for the post of Assistant Warden (for Girls) (Applications received from the male candidates for the post of Assistant Warden (for Girls) will be summarily rejected)
- 5.5 The candidates shall mention their correct and active e-mail addresses and Mobile number in their application form at prescribed place, as correspondences viz. call letters/ admit cards or any other information may be communicated through email.
- 5.6 Any updates with regard to this recruitment drive shall be published on NIFT Kolkata's website (<a href="https://www.nift.ac.in/kolkata/careers">https://www.nift.ac.in/kolkata/careers</a>). The applicants are requested to follow our said website on regular basis.
- 5.7 The candidates who are in private university/ organization, who are eligible, need to submit an undertaking/self-declaration to the effect that <u>"No penalty has ever been imposed on him/her and he/she</u> has never been convicted by any Court of Law".
- 5.8 Certificate in support of experience should be given by Appropriate Authority clearly mentioning the period in that particular organization / Institution.
- 5.9 No TA/ DA shall be payable to any candidate for attending written/ skill test.
- 5.10 Incomplete/unsigned/illegible applications and applications received without fee/ photograph/ certified copies of required certificates such as educational qualifications, caste/community etc., and those received after the prescribed last date, will summarily be rejected without any communication to the candidate. No further correspondence will be entertained in this regard.
- 5.11 NIFT will not be responsible for any postal delay/ loss in transit in submission of application within specified time.
- 5.12 Essential Qualification, Experience and Age will be reckoned on the last date for submission of Applications i.e. 11.03.2022

#### **IMPORTANT INSTRUCTIONS:**

- 1. Candidates should read the instructions and conditions carefully before applying.
- The posts are to be filled up on contract basis initially for a period of 03 years and may be renewed further based on the performance of the candidate & Institute's requirement with provision for regularisation subsequently on completion of 05 years of contract service subject to eligibility and as per NIFT policy.
- 3. Mere fulfilling of essential qualifications and experience may not entail a candidate to be called for selection process. The decision of the Institute shall be final and binding on all the candidates.
- 4. No correspondence will be entertained from the candidates regarding the eligibility, status of applications, postal delays, conduct and result of test etc. either before or after the selection.
- 5. Incomplete/unsigned applications and applications received without prescribed fee, photograph, attested copies of required certificates such as educational qualifications, caste/community/ experience etc. and those received after the prescribed last date for receipt of application, will summarily be

- rejected without any communication to the candidate. No further correspondence will be entertained in this regard.
- 6. The Institute reserves the right to consider candidates for selection by suitable selection procedure and at its discretion may conduct written test /skill test for above posts to select the candidates on the basis of merit.
- 7. NIFT will not be responsible for any postal delay / loss in transit in submission of application within specified time.
- 8. Wrong declarations/ submissions of false information or any other action contrary to law shall lead to cancellation of the candidature at any stage. - 17. No application under RTI Act, 2005 shall be entertained during the entire recruitment process. NIFT reserves the right to decide on disputes, if any and decision of appropriate authority of NIFT shall be final and binding.
- 18. No interim enquiry or correspondence will be entertained. Candidates are advised to visit the said NIFT website regularly for any updates regarding the recruitment drive.
- 19. Employment in institute shall be governed by the NIFT Act, Statutes, Ordinances, Rules & Regulations or General Service Rules of NIFT as amended from time to time.
- 20. Applications once made will not be allowed to be withdrawn on any count nor can it be held in reserve for any other recruitment or selection process.
