Applications are invited in the prescribed format from the retired Government Employees who retired on superannuation from L & L.R. Deptt. on or before 31/12/2021 to fill up, on contractual basis, the following posts upto 64 years of age for the U.C.C. under L.R. Set Up. Government employees who retired as R.O./ SRO-II/SRO-I will only be eligible to apply for the post of R.O., retired R.I. will only be eligible to apply for the post of R.I. and government employees who retired as Amin or Surveyor or Draftsman will be eligible to apply for the post of Amin.
