6. Maximum Age-limit: -

Tutor: - Not exceeding 30 (Thirty) years as on the date of publishing this notification in Institute website.

(i) Upper age limit shall be determined as on the date of publishing this notification in Institute website.

(ii) No age relaxation would be available to SC/ST/OBC Candidates applying for unreserved vacancies.

(iii) Age relaxation permissible to various categories is as under: -

7. Candidates applying under any of the reserved category posts, viz. OH will be considered subject to OH Certificate issued by the appropriate/ Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate.

8. Only such persons would be eligible for reservation under OH quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format.

9. The candidates are to satisfy all eligibility criteria. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.

10. The post of Tutor will be governed by CCS (Temporary Service) Rules.
