CIRCULAR

It is being informed to all Superintendents of District Hospitals and all other Superintendents and all other concerned authorities that the tenure of current batch of house staffs in different disciplines of the Hospitals concerned may be extended up to May, 2022.

Further all Superintendents of District Hospitals and all other Superintendents and all other concerned authorities are informed that like previous year (i.e. 2021-2022) in this year (i.e. 2022-2023) also the Selection of House-Staffship will be held in decentralized way after the extension period allowed till May 2022 and the selection procedure may be conducted locally by the concerned authorities as per govt, guidelines for House-staffship selection. Accordingly, further necessary notice for engagement of House-staffs must be issued by the different concerned authorities from the respective ends at appropriate time.

The Superintendents of the District Hospitals and other Health Institutions, having Sanctioned Posts of House-Staff are empowered to appoint Stipendiary House-Staff locally in the vacant posts and the concerned authorities should follow the existing rules & guidelines vide memo. No. ME/HS-03-10/M/616 dt.25.04.2013.

The said authorities are instructed to complete the procedure of selection locally at their respective Institutions and submit the list of Selected House-Staff to the undersigned for approval & further necessary action.

All candidates who applied or intend to apply for house-staffship are instructed to apply to the concerned local authorities of Health Institutions or Medical College of their choice as per notification of local authorities.

This will take immediate effect until further order.
