In terms of Memo no HFW/NRHM/272/2010/875 dated 26/02/2014 of State Mission Director, NRHM and subsequently memo no. – HFW/NRHM/272/2010 Pt.I/2087 dated 23/06/2022 Mission Director, NHM & Secretary, Health & Family Welfare Department West Bengal, the application is invited for filling up the existing vacancies of BPC (ASHA) at Egra Sub-Division in prescribed format.

Applications can be submitted directly or by Speed post /Registered post only at the office of the Sub-divisional Officer; Egra from 01.09.2022 to 21.09.2022. Applications will be received on every Monday to Friday (11.00 AM to 5.00 PM) from the date of notification excluding Government Holidays, Saturdays and Sundays, if any. Applications are received after that time will be rejected (i.e., after 5.00 pm of 21/09/2022). In case of applications by Speed post /Registered post, the authority will not be responsible for any postal delay causing rejection of application.

Applications are invited from eligible candidates for engagement to the post of Block Programme Coordinator (ASHA) (on contractual basis) to be posted at Patashpur-II Block Egra Sub-Division, Purba Medinipur District. Details are given in the table below:-

Selection Criteria:-

a. Academic Qualification: Master's degree in Social Science/ Sociology /Social Anthropology/Social Work (MSW)/ Business Administration (MBA)/Economics/ Rural Development/ Mass Communication OR

Graduate degree in any discipline with minimum 2 years' experience in health projects

- a. Preference will be given to candidates having working experience in ASHA programme
- b. Knowledge in MS Office & Internet. If any certificate is available with the candidate, it may be provided. But the computer test will be the final and only decisive factor for ascertaining the computer skills of the candidate.
- c. Ability to communicate effectively
- d. Willing to travel extensively
- e. Should be a resident of Egra Sub Division.
- f. For ST candidates, upper age relaxation will be 5 years from 40 years (that is, not more than 45 years as on 01/01/2022).

Monthly Remuneration:-

Rs.15000.00 / month. In addition, he/she will be eligible for a monthly mobility support of Rs.1800.00

Existing employees working in the same position may also apply on own choice. In that case five (5) years relaxation of age from the date mentioned in the recruitment notification will be given to such employees. But will not be entitled to any other benefits of the present position such as continuity of length of service, rationalization benefits and any other benefit, if applicable, against that post. Such employees will start as a fresher in the new position, if selected.

The posts are purely contractual in nature with initial period up to 31.03.2023; renewable based on budgetary sanction and performance. The selection will be based on merit (academic result of H.S, Graduation and Master Degree) and experience in health projects along with written test, Computer skill test.
