## B. Other General Guidelines:-

1. The applicant should be a citizen of India.
2. **Mode of Selection:**
  - a. On the basis of the evaluation of educational qualifications, top 20 candidates will be called for Computer Test and Interview. Each candidate will be evaluated as follows:

i.	Evaluation of Educational Qualification	-30Marks (Maximum)
ii.	Computer Test (Practical)	-15Marks
iii.	Interview	-5Marks

  - b. Evaluation of Educational Qualification:
    - **In Graduate Examination :**
      - If marks obtained less than or equal to 50% = 5 marks
      - If marks obtained less than 60 % and greater than 50% = 7 marks
      - If marks obtained more than or equal to 60% = 10 marks
    - **If candidate is Honours. Graduate, He / She will get Extra weightage of 5 Marks for Hons. Degree over and above the marks mentioned above.**
    - **In Post Graduate Examination :**
      - If marks obtained less than or equal to 50% = 5 marks
      - If marks obtained less than 60 % and greater than 50% = 10 marks
      - If marks obtained more than or equal to 60% = 15 marks

4. Applications with required documents will be received **through a dedicated e-mail ID only – recruitmentpopwv@gmail.com**. The application must be signed by the candidate and signed copy of the application form should be sent by mail in pdf format. No application will be received by hand, by post or by any other means.
5. Last date of application is 19.02.2023 upto 11:59 pm. Application received after the closing date and time will be summarily rejected.
6. Following **self-attested documents** should be attached alongwith the application form in pdf format:-
  - a) Age Proof: (Any one of Birth Certificate / Admit Card or Certificate of Secondary Examination).
  - b) Educational Qualification: Mark sheets of Graduation/Hons. Graduation and Post-Graduation.
  - c) Experience Certificate.
  - d) Caste certificate if any.
7. District Level Selection Committee reserves the right to reject any application, not properly filled in or received after due date & time etc. It also reserves the right to cancel/postpone/suspend any engagement to any aforesaid post at any point of time.
8. Candidature of any candidate shall be rejected straightway if found not eligible at any stage even after appearance at Computer Test, Interview or Engagement.
9. The engagement will be on purely contractual basis and temporary mode. If any candidates was previously terminated from the contractual service for dissatisfactory performances or otherwise, he / she will not be eligible to apply for the post. A declaration in this regard is to be furnished with the application.
10. Initially the engagement will be for one year after which tenure of service may be renewed from the end of this department on satisfactory performance.
