Applications received through online mode after 23.02.2023 will also be rejected and delay due to technical or any other issue, if any, will not be considered.
- 4. Each Candidate will be evaluated as per the following scoring system:
 - i) Evaluation of educational qualification 30 marks
 - ii) Computer test (practical) 15 marks
 - iii) Viva voce 5 marks
- 5. After evaluation on the basis of educational qualification, the Selection Committee will call top 20 candidates for Computer Test and Viva voce. Admit Card for the same will be emailed to the concerned candidates.
- 6. A panel of 3 top ranking candidates will be prepared, which will be valid for 1 (one) year from the date of publishing of the same. Top ranking candidate in the panel will be offered to join the post.
