#### Following will be the probable job specifications of the Consultant Physician:

- To provide medical consultations to students and employees of the Institute.
- To monitoring the reports of Temperature and symptoms of COVID-19 inside the campus to students and employees including placement agency / security service and housekeeping service and all AMC vendors visiting the campus on daily basis.
- The medical consultant will be required to be available **Monday to Friday from 4:00 pm to 7:00 pm** in the institute and shall provide services to the students and staff members of Indian Institute of Foreign Trade, Kolkata Campus. *However he /she should be available round the clock for any sort of emergency*.

#### Note:-

- Number of days in week in respect of doctor can be increased or decreased as per the requirement of Institute.
- Medicines will be provided by the Institute as per requirement submitted by the Doctor.
- The engagement of Medical Consultant is purely temporary. No claim shall lie for regular employment on that basis at any stage.
- The Medical Consultant will not be entitled for any leave and any other benefits enjoyed by the employees of IIFT.
- In case of Emergency, student may contact Doctor for advice and Consultancy.

#### **Tenure:**

The appointment will be purely on contract basis initially for a period of one year. The tenure can be extended further depending upon performance of the candidates and requirement of the Institute.
