Notification for Engagement of Part Time Homeopathic & Ayurvedic Doctors on Retainership

The terms and condition of part time retainership are outlined below:-

Homeopathic Doctor:

The Homeopathic Doctor is required to attend dispensary at HAL Barrackpore Division, from 1200 Hrs to 1635 Hrs on Monday, Wednesday & Friday (Except Holidays as notified by HAL Barrackpore Division). The Homeopathic Doctor is required to provide consultancy / treatment to the employees of HAL Barrackpore Division and their dependent family members.

Ayurvedic Doctor:

The Ayurvedic Doctor is required to attend dispensary at HAL Barrackpore Division, from 1200 Hrs to 1635 Hrs on Tuesday & Thursday and from 0830 Hrs to 1300 Hrs on Saturday (Except Holidays as notified by HAL Barrackpore Division). The Ayurvedic Doctor is required to provide consultancy / treatment to the employees of HAL Barrackpore Division and their dependent family members.

Eligibility Criteria:

- i) Qualification:
- a) <u>Homeopathic Doctor</u>: Degree in Homeopathy (BHMS) from a recognized University / Statutory State Board / Council of equivalent recognized under the Homeopathy Central Council Act, 1973 and having valid enrolment on the Central / State Register of Homeopathy.
- b) <u>Ayurvedic Doctor</u>: Degree in Ayurveda (BAMS) from a recognised University / Statutory State Board/Council of equivalent recognized under the Indian Medicine Central Council Act, 1970 and should have valid enrolment on the Central / State Register of Ayurveda.
- ii) <u>Experience</u>: Should have minimum 5 Years post qualification Experience in Govt. Hospitals / Institutions / Dispensaries / PSUs / Private Sector / Charitable Hospitals / Dispensaries
- iii) Maximum Age Limit: Should not be more than 62 years of age as on 01/12/2023

<u>Period of Retainership</u>: The Initial retainership is for a period of 2 years with a provision of 01 year extension or till he/she attend the age of 65 years (whichever is earlier).

<u>Remuneration</u>: Consolidated Retainer fees of Rs. 9800/- per month. In case of absence of retainer for attending dispensary, consolidated retainer fees will be paid on pro rata basis. No other allowances or benefits are admissible to the retainer other than those indicated above.
